DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 13TH OCTOBER 2020

HIGHLIGHTS

- Two hundred and twenty-five (**225**) confirmed cases were reported in the last 24 hours from **11** states – Lagos (165), FCT (17), Rivers (13), Ogun (12), Niger (8), Delta (4), Ondo (2), Anambra (1), Edo (1), Ekiti (1) and Kaduna (1).
- Sixty-five (**63**) discharges have been reported in the last 24 hours in **six** states – Plateau (26), Kaduna (14), Anambra (10), Rivers (8), FCT (4) and Ogun (1).
- **One** death was reported in the last 24 hours in **one** state – Osun.
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

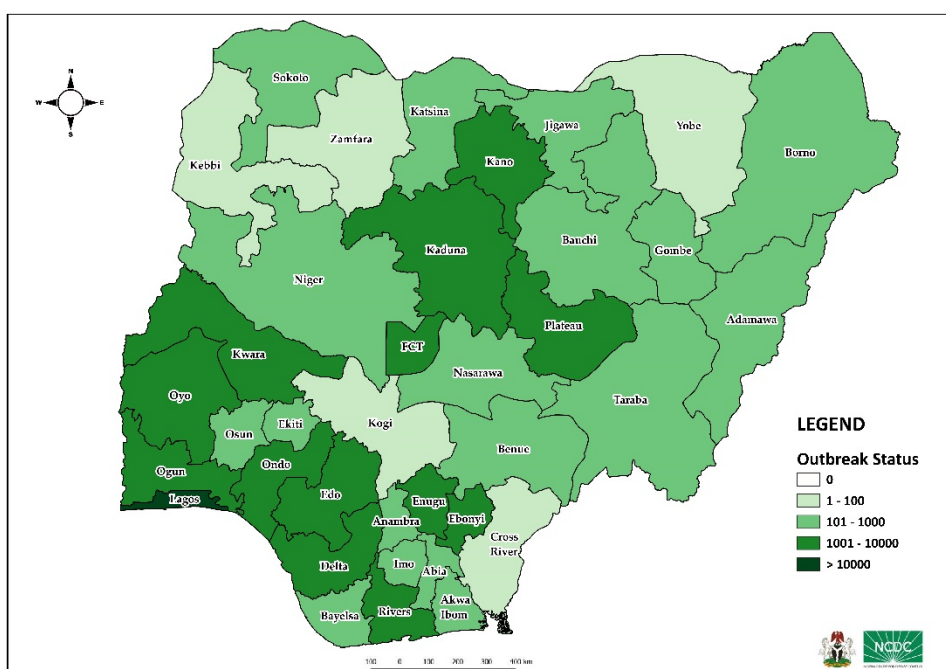

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK42)

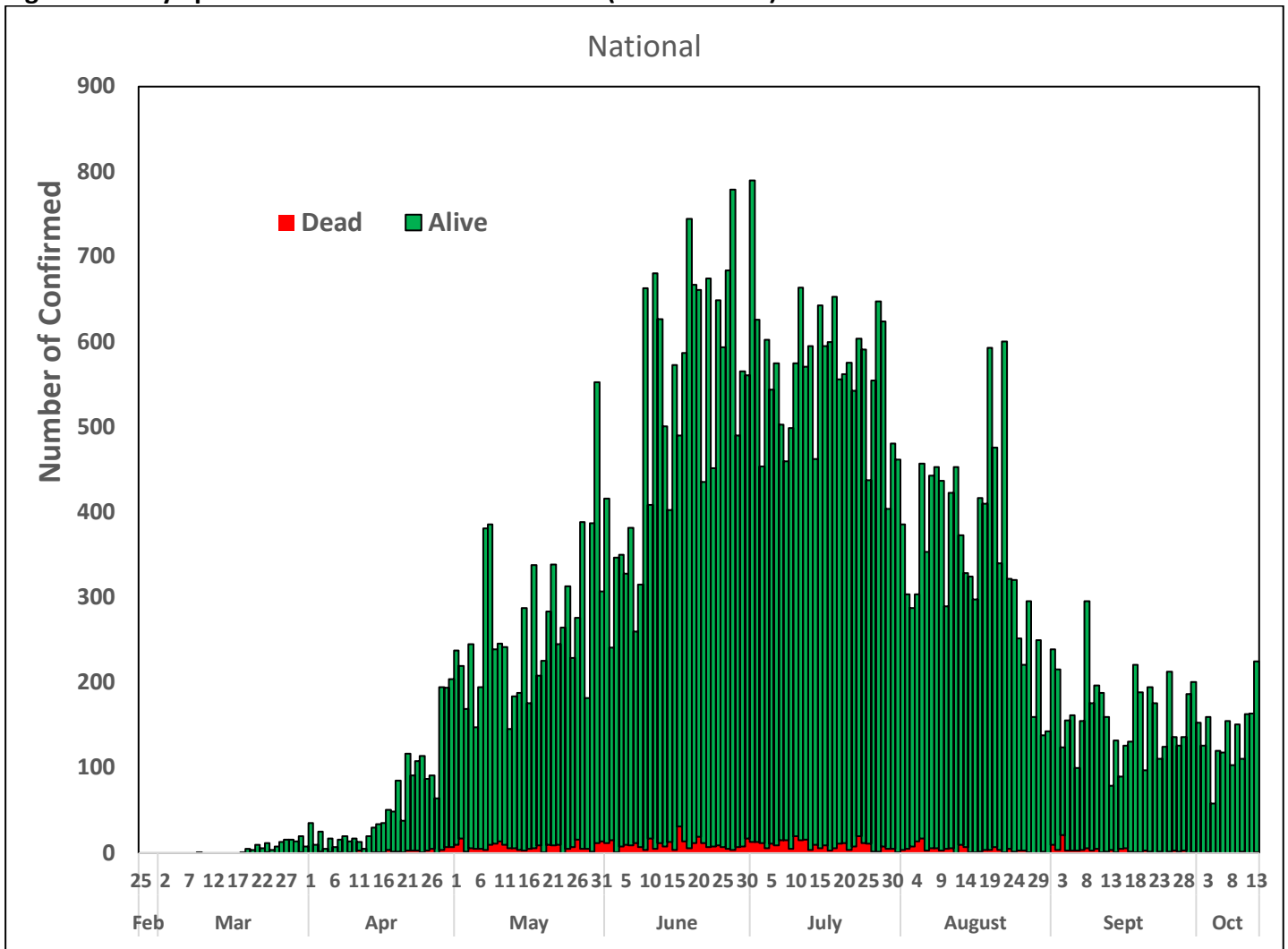
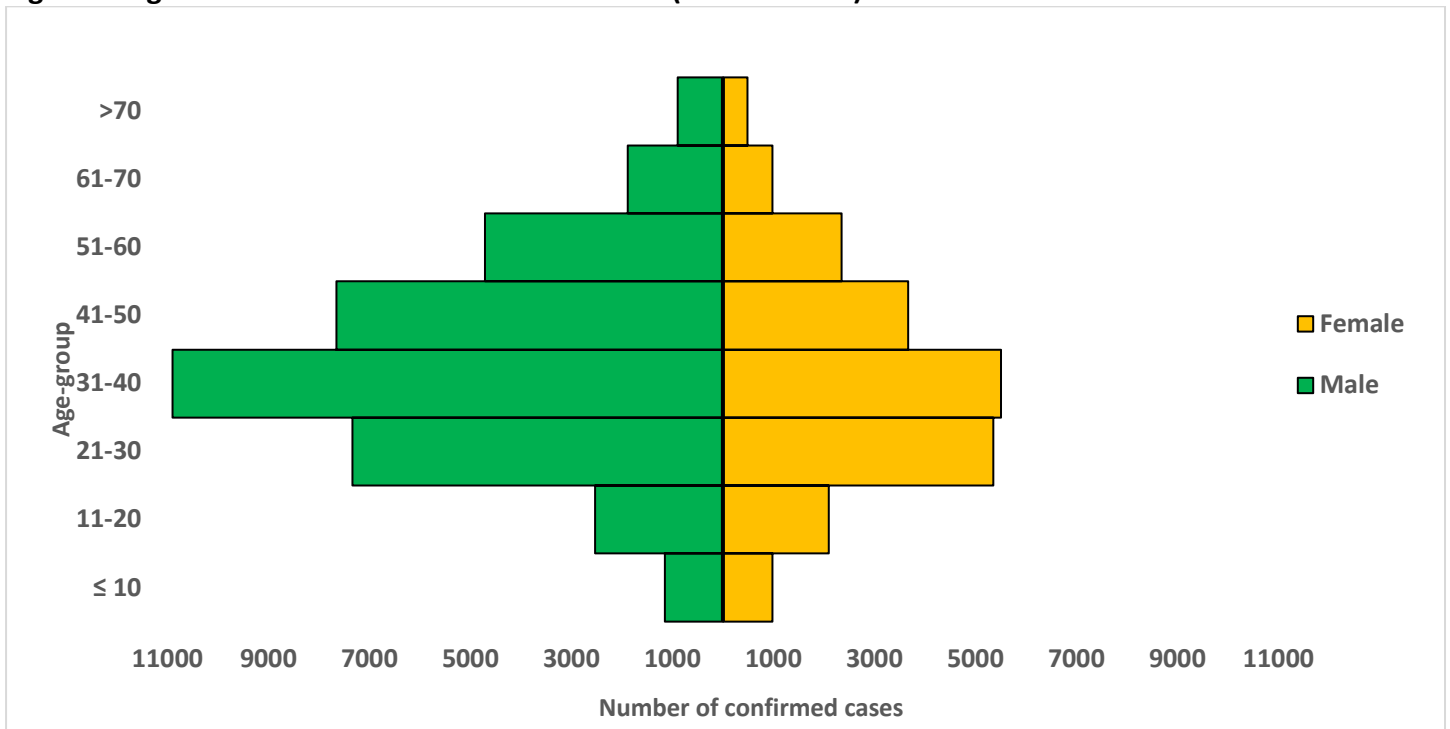


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK42)

RESPONSE

On 28th February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria – led by NCDC in close coordination with the State Public Health EOCs (PHEOC).
