DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 19th JUNE 2020

HIGHLIGHTS

- Six hundred and sixty-seven (**667**) confirmed cases were reported in the last 24 hours from twenty-three (**23**) states – Lagos (281), Abia (48), Oyo (45), FCT (38), Ogun (37), Enugu (31), Ondo (23), Plateau (21), Edo (19), Delta (18), Rivers (18), Bayelsa (17), Akwa Ibom (17), Kaduna (14), Kano (12), Bauchi (9) Gombe (4), Osun (3), Benue (3), Nasarawa (3), Kwara (3), Ekiti (2) and Borno (1).
- No new state recorded a confirmed COVID-19 case in the last 24 hours. The total number of states including FCT that have reported at least one confirmed case in Nigeria is still **36** (35 states + FCT).
- Two hundred and seventy-four (**274**) cases were discharged in the last 24 hours in seventeen (**17**) states – Abia (73), FCT (67), Gombe (29), Lagos (23), Kwara (22), Rivers (16), Delta (15), Borno (9), Anambra (7), Nasarawa (4), Ekiti (2), Ogun (2), Bayelsa (1), Benue (1), Edo (1), Jigawa (1) and Kano (1).
- Twelve (**12**) deaths were recorded in the last 24 hours in five (**5**) states – Bayelsa (6), Abia (3), Borno (1), Ondo (1) and Rivers (1).

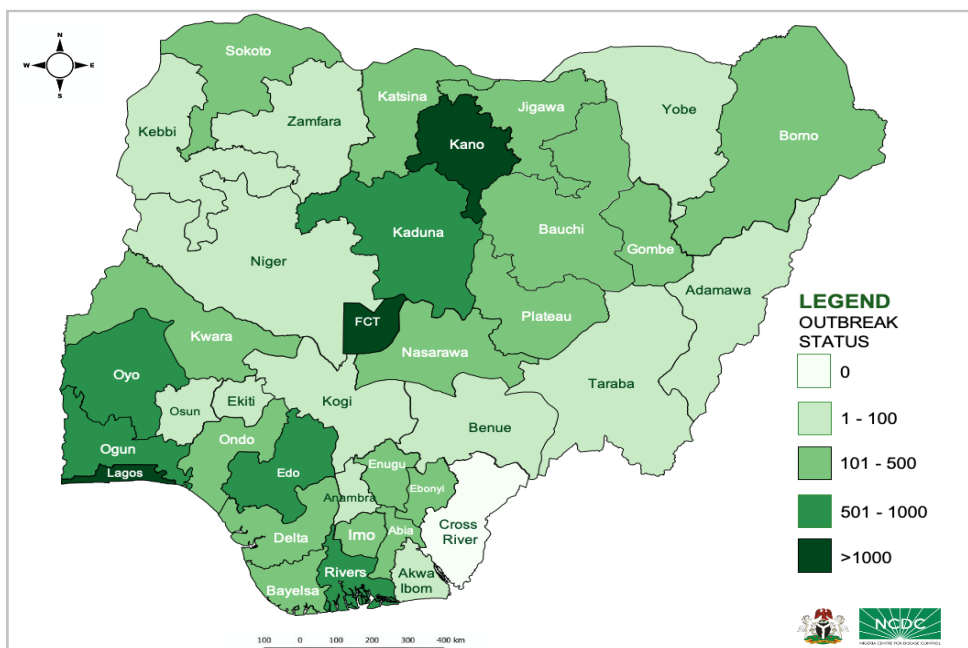

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK25)

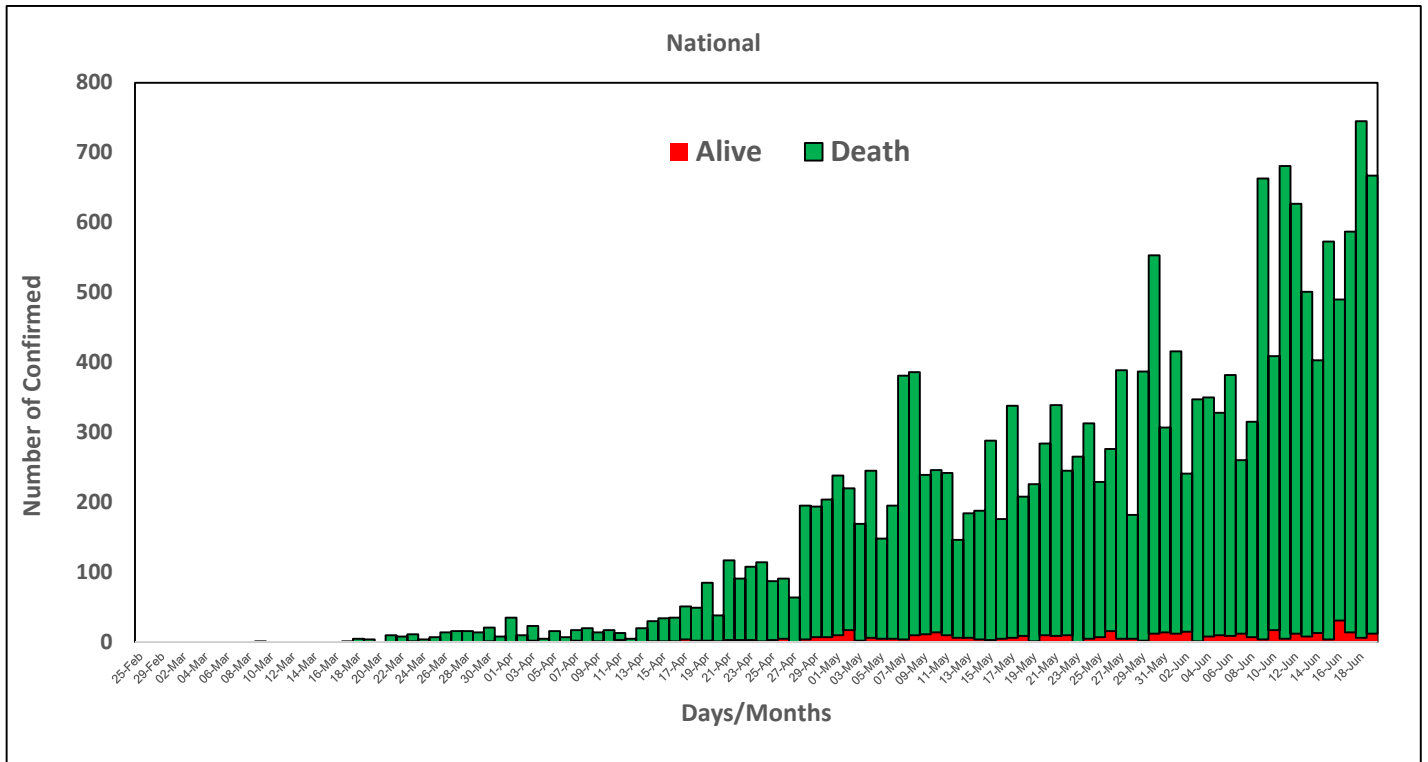
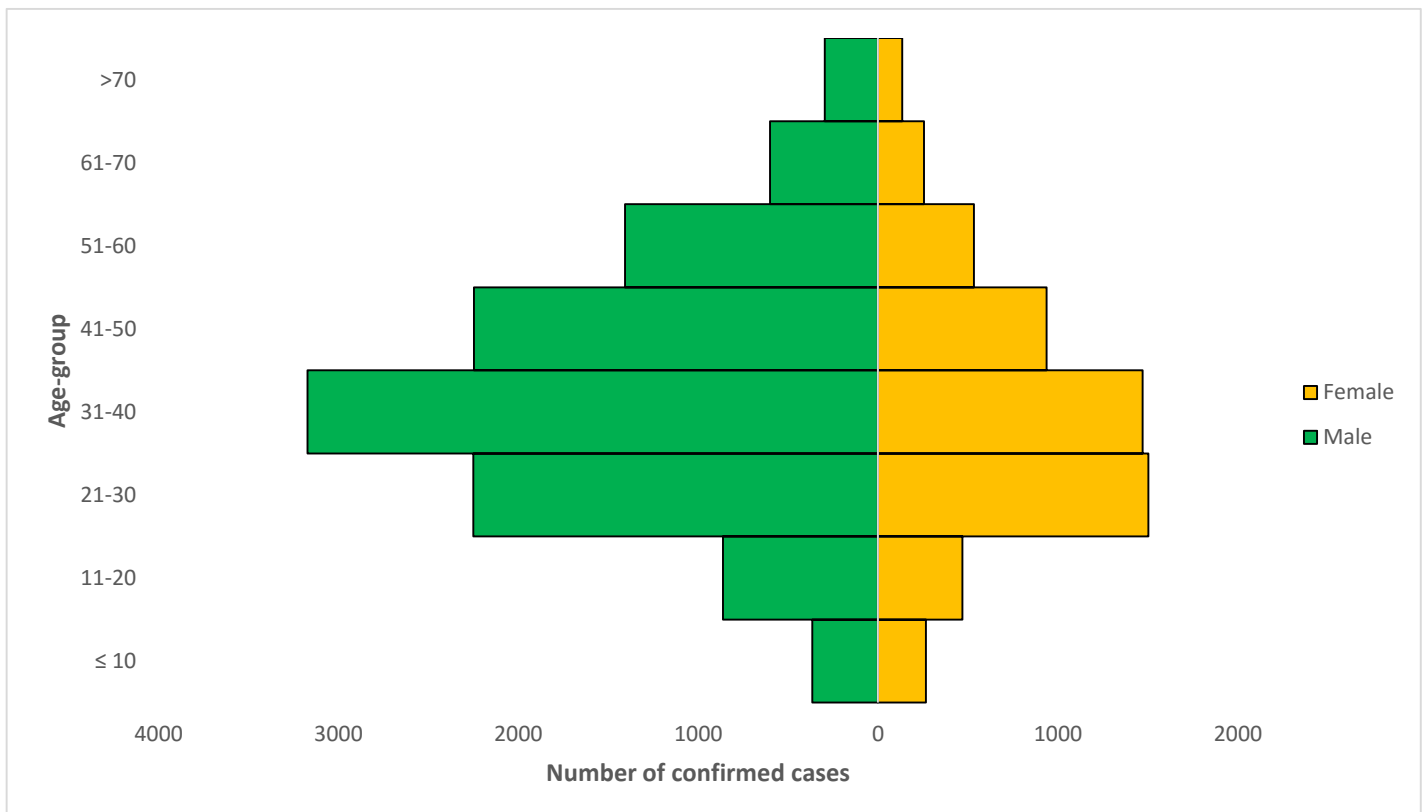


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK25)



PREPAREDNESS

Since the confirmation of the first case on 27th February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

- NCDC has released [guidelines on the re-opening of places for worship](#).
- The Nigeria Police Force has released COVID-19 operational guidelines for the [Police and other Law Enforcement Agencies](#) in Nigeria
- NCDC and the Department of Hospital Services (Federal Ministry of Health) have updated the [case management guidelines](#) (version 3) with reviewed changes such as the discharge criteria and medication being used for the treatment of cases
- Guidelines have been issued for the [safe transportation of remains of persons suspected or confirmed to have died of COVID-19](#)

- To increase our testing capacity, NCDC has issued guidelines for the [integration of private labs](#).
- Guidelines for [businesses and employers](#) have been updated.

- NCDC releases periodic [public health advisories](#) to Nigerians on the COVID-19 disease.

RESPONSE

On 28th February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Engagement of Surveillance and Laboratory teams to improve Turn Around Time (TAT) from sample collection , communication of tests result and issuing of test certificate**
- **SORMAS and Laboratory teams developed an automated electronic system model design to improve data quality and synchronise Laboratory information system**
- **Received a total 243 Persons of Interest (POIs)/returnees, 51 Pakistan, 181 Dubai and 11 Mozambique**
- **Distributed travellers kits, guidelines and POIs/returnees were issued COVID-19 test appointments at the airport**
- **Distribution of Personnel Protective Equipment (PPEs) to General Hospitals (GHs) and Primary Health Care facilities (PHCs) in Bayelsa State**
- **Support Supervision provided in holding areas in GHs, PHCs and private facilities to ensure Screening, Isolation and Notification (SIN)**
- **Identified IPC focal persons in health facilities in Bayelsa**
- **Developed new graphics for COVID-19 symptoms and guidelines on re-opening of religious centres**
- **Created a toolkit for opening of religious centres**

- **Distribution of Information Education and Communication (IECs) materials to General Hospitals (GHs) and Primary Health Care facilities in Bayelsa State**
- Deployment of an additional Rapid Response Team (RRT) to Gombe State
- Lab optimisation ongoing in Ondo
- Development of draft guidance for states on reporting loss of follow up cases
- Ongoing daily review of Surveillance Outbreak Response Management and Analysis System (SORMAS) data quality
- Conducted a teleconference with State Clinicians and stakeholders on management of COVID-19 patients
- Distributed IPC job aids to all health facilities in Osun State
