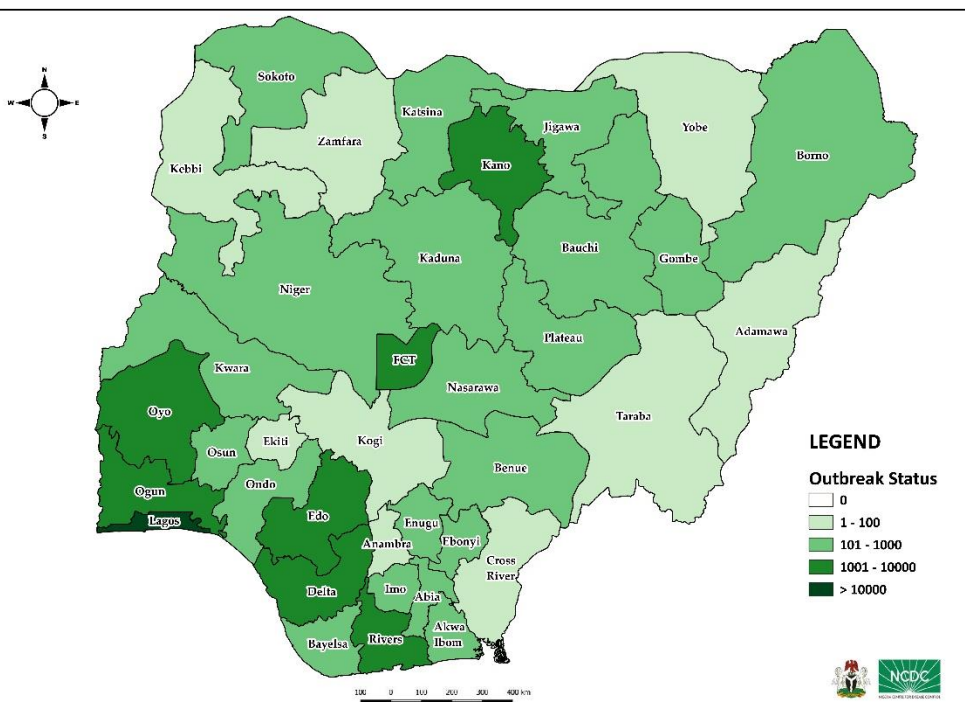
DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 10TH JULY 2020

HIGHLIGHTS

- Five hundred and seventy-five (**575**) confirmed cases were reported in the last 24 hours from **18** states – Lagos (224), Oyo (85), FCT (68), Rivers (49), Kaduna (39), Edo (31), Enugu (30), Delta (11), Niger (10), Katsina (9), Ebonyi (5), Gombe (3), Jigawa (3), Nasarawa (2), Plateau (2), Borno (2), Abia (1) and Kano (1).
- Two hundred and forty-nine (**249**) cases were discharged in the last 24 hours in **11** states – Oyo (91), Lagos (63), FCT (24), Kaduna (21), Bayelsa (12), Niger (11), Ogun (10), Anambra (8), Rivers (4), Edo (4) and Plateau (1).
- **Twenty (20)** deaths were recorded in the last 24 hours in **five** states – Lagos (14), Plateau (2), Rivers (2), Bayelsa (1) and Jigawa (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK28)

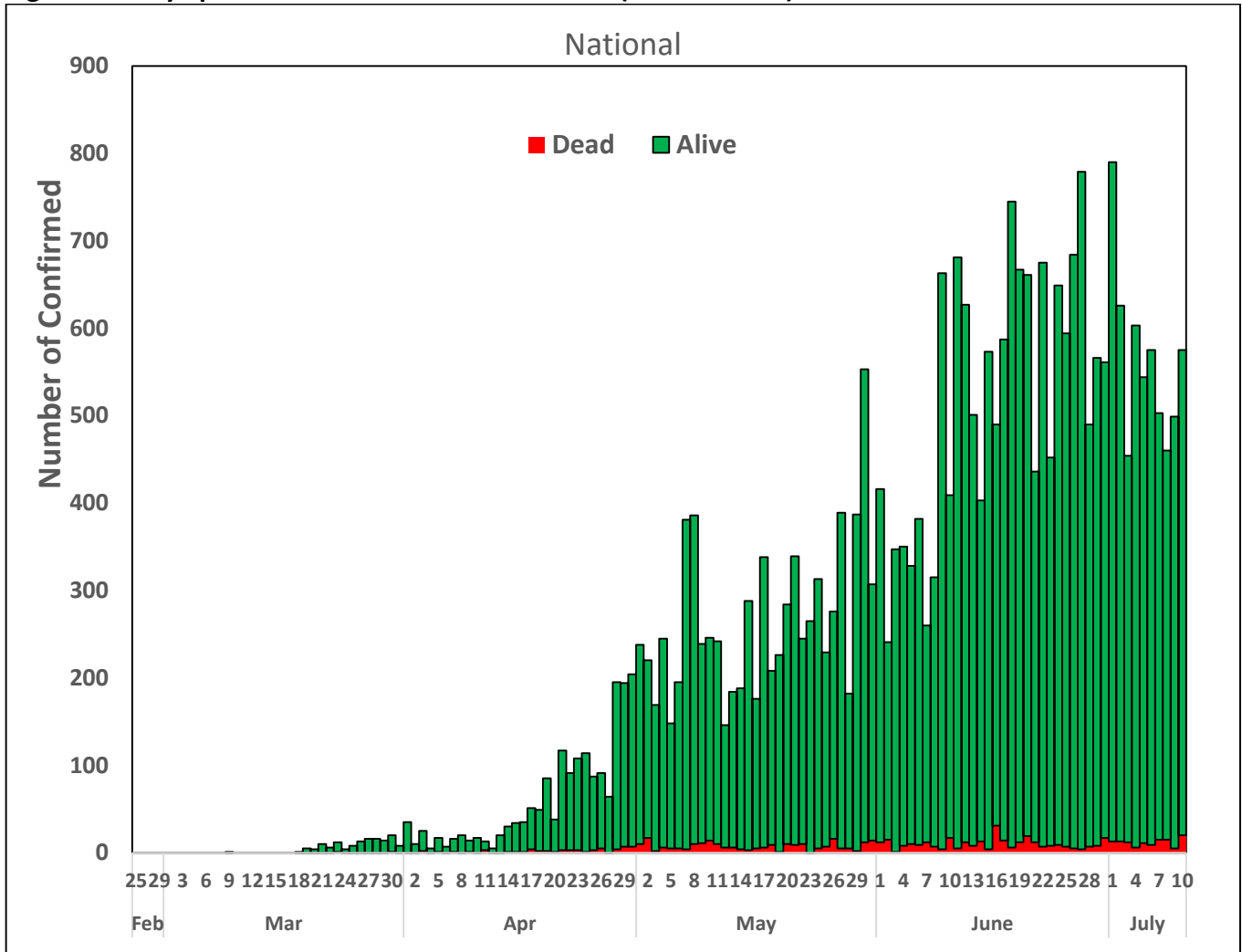
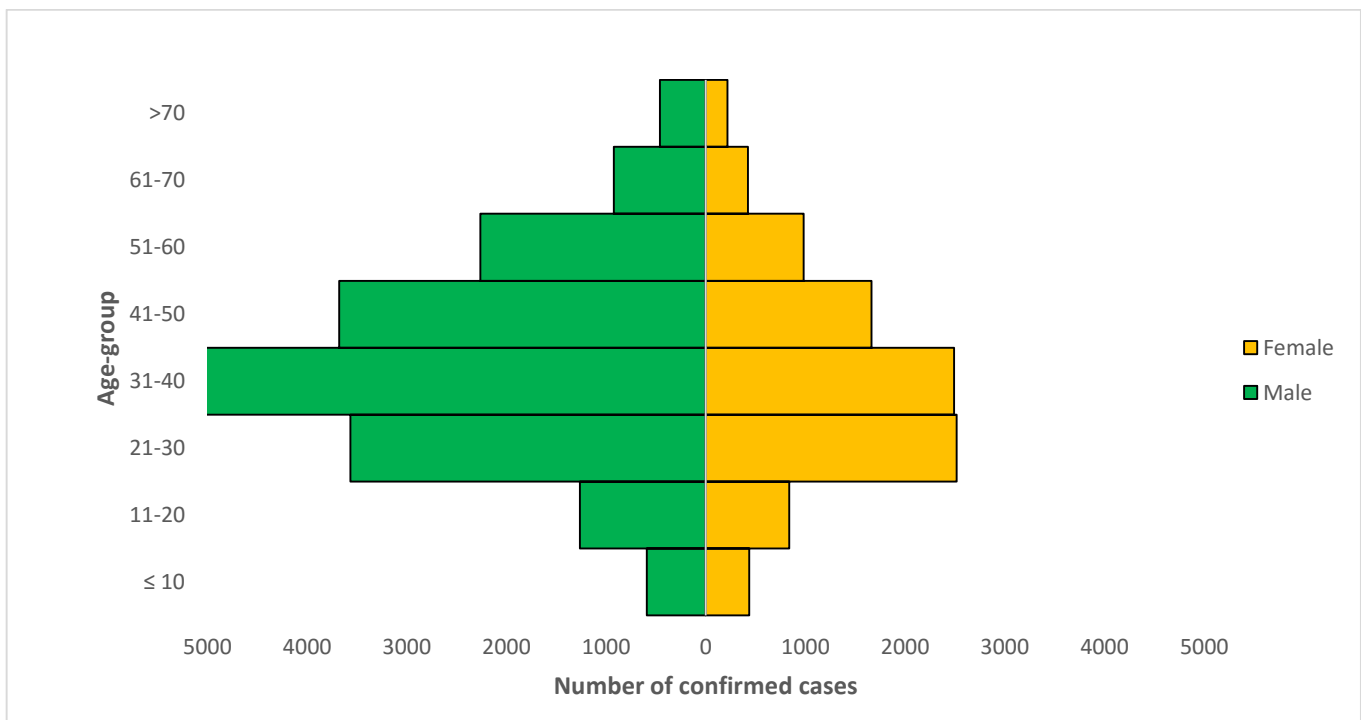


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK28)



PREPAREDNESS

Since the confirmation of the first case on 27th February 2020, the NCDC has released advisories and statements to help Nigerians and affected groups in particular to respond to the pandemic

- NCDC has released [guidelines on the re-opening of places for worship](#).
- The Nigeria Police Force has released COVID-19 operational guidelines for the [Police and other Law Enforcement Agencies in Nigeria](#)
- NCDC and the Department of Hospital Services (Federal Ministry of Health) have updated the [case management guidelines](#) (version 3) with reviewed changes such as the discharge criteria and medication being used for the treatment of cases

RESPONSE

On 28th February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Finalised and approved 18 States` Incident Action Plan (IAP) for ₦100M NCDC/World Bank financial support on implementation of prioritised activities**
- **Deployment of Grant Agreement (GA) to Benue and Rivers States**
- **Cumulatively, 1960 Persons of Interest (POIs)/returnees have been received since inception of the revised protocol. Of this, 1325 (67.6%) samples were collected. From the results released positives were 145 (10.9%), negatives were 977 (73.7%) while 203 (15.3%) are pending in Lagos State**
- **Tracking of daily sample collection from states**
- **Ongoing optimisation of a new Polymerase Chain Reaction (PCR) laboratory in Abia State**
- **Ongoing investigation of Healthcare Associated Infection (HAI) in Federal Medical Centre (FMC), Bida and Enugu health facilities**

- **Conducted weekly refresher trainings for healthcare workers in Treatment Centres (TCs) in Kebbi State**
- **Deployment of Personal Protective Equipment (PPEs) and commodities to laboratories within the network in Ibadan, Kaduna and Katsina**
- **Supplied PPE and laboratory commodities to sample collection sites across FCT**
- **Conducted community assessment on willingness to adhere to Non-Pharmaceutical Interventions (NPIs) for COVID-19 in Kano, Rivers and Lagos**
- Participated in the Presidential Task Force on COVID-19 Mid Term Review
- Received a total of 77 Persons of Interest (POIs)/Returnees from India (63) and Cote D'Ivoire (14)
- Conducted implementation planning meeting for Training of Trainers (TOT) for state teams health care workers and community volunteers on COVID-19 surveillance
- Conducted training for 30 members of the Imo State IPC committee
- Ongoing orientation of leadership of private health care facilities on IPC best practices and minimum standards in Imo State
- Supply of Personal Protective Equipment (PPE) to laboratories within the national network in Oyo State
- Supplied laboratory materials for the activation of the GeneXpert testing laboratory at the University of Abuja Teaching Hospital, Gwagwalada
- Completed data collection for First Few Cases (FFX) Study in the FCT
- Finalised the completion of three manuscripts and made ready for submission
- Ongoing development of full-scale risk assessment tools for school reopening
