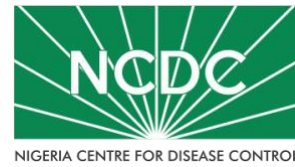


# COVID-19 SITUATION REPORT

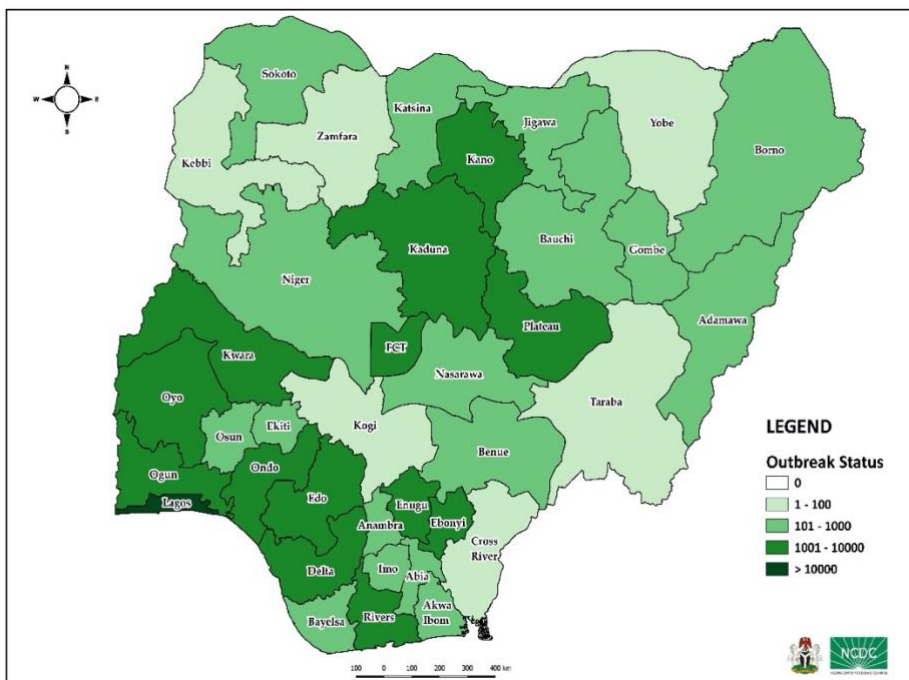
DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 15<sup>th</sup> SEPTEMBER 2020

### HIGHLIGHTS

- Ninety (**90**) confirmed cases were reported in the last 24 hours from **eight** states – Lagos (33), Plateau (27), Kaduna (17), Ogun (6), FCT (4), Anambra (1), Ekiti (1) and Nasarawa (1).
- Ninety-three (**93**) discharges have been reported in the last 24 hours in **five** states – Plateau (47), Kaduna (21), Ogun (17), Edo (7) and Cross River (1).
- **Five** deaths were reported in the last 24 hours in **three** states – Edo (3), Cross River (1) and Lagos (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK38)

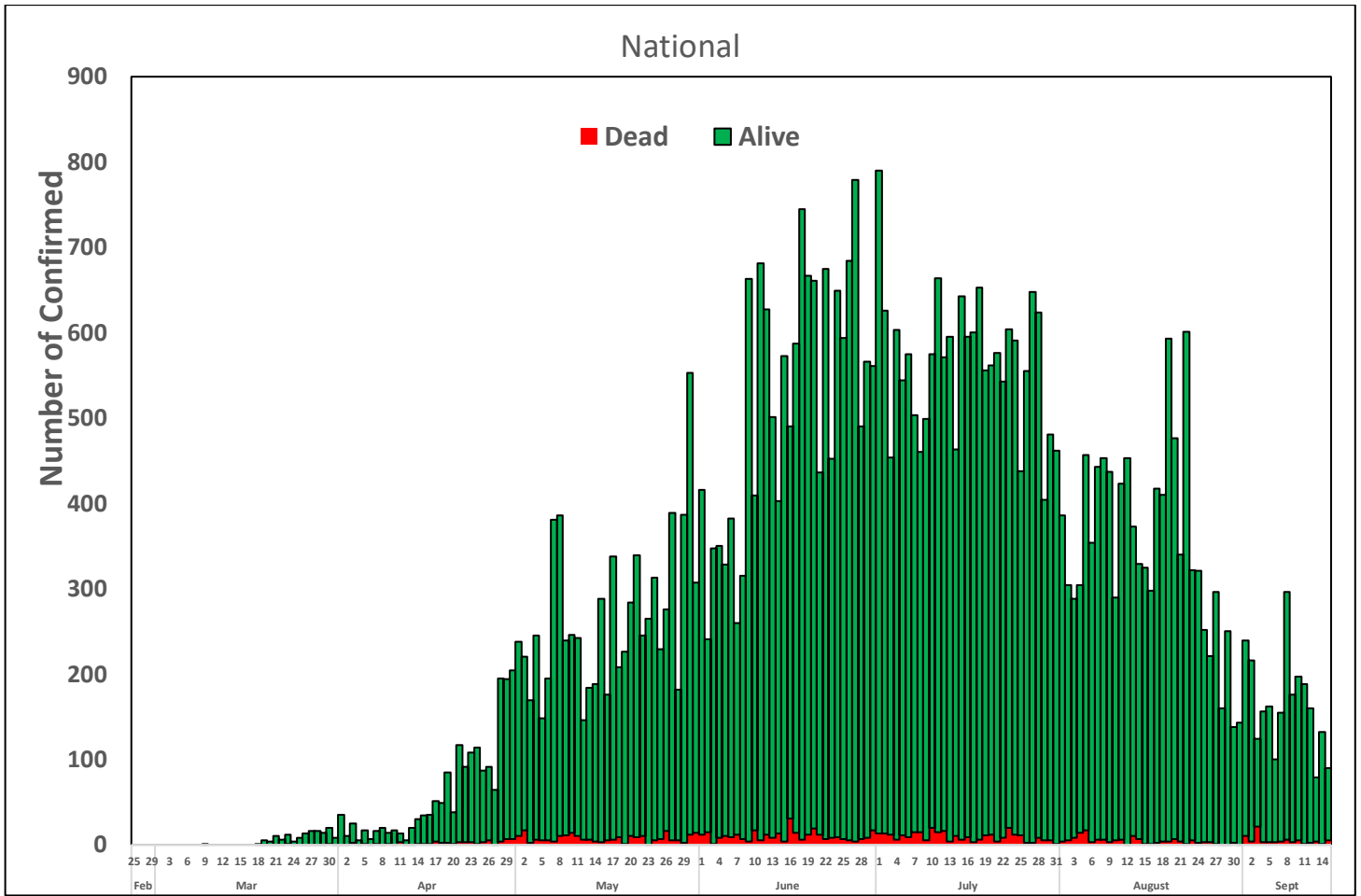
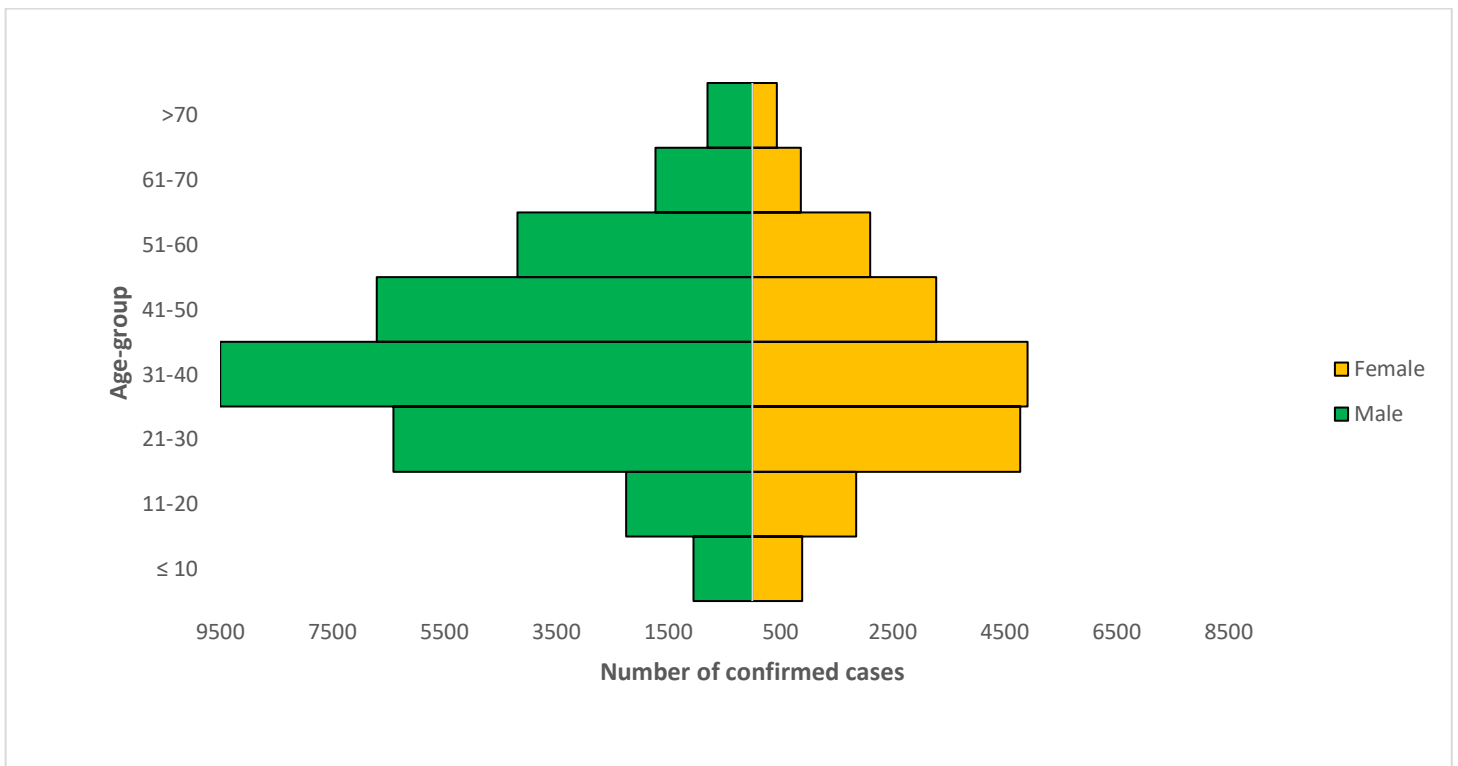


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK38)

## RESPONSE

On 28<sup>th</sup> February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Published the revised guideline on Infection Prevention and Control (IPC) for COVID-19 during health care delivery**
- **Completed September deployment of response materials and commodities to all states**
- Disseminated draft guidelines, protocols and checklists to states for preparation and engagement with respective State Ministries of Education and stakeholders towards school re-opening
- Trained senior officers of the Nigeria Security and Civil Defence Corps (NSCDC) to be deployed for the upcoming elections in Edo & Ondo states on IPC measures
- Engaged with technical assistants deployed to states to support states risk communication teams on the use of risk communication needs assessment and reporting tools
