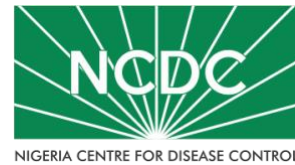

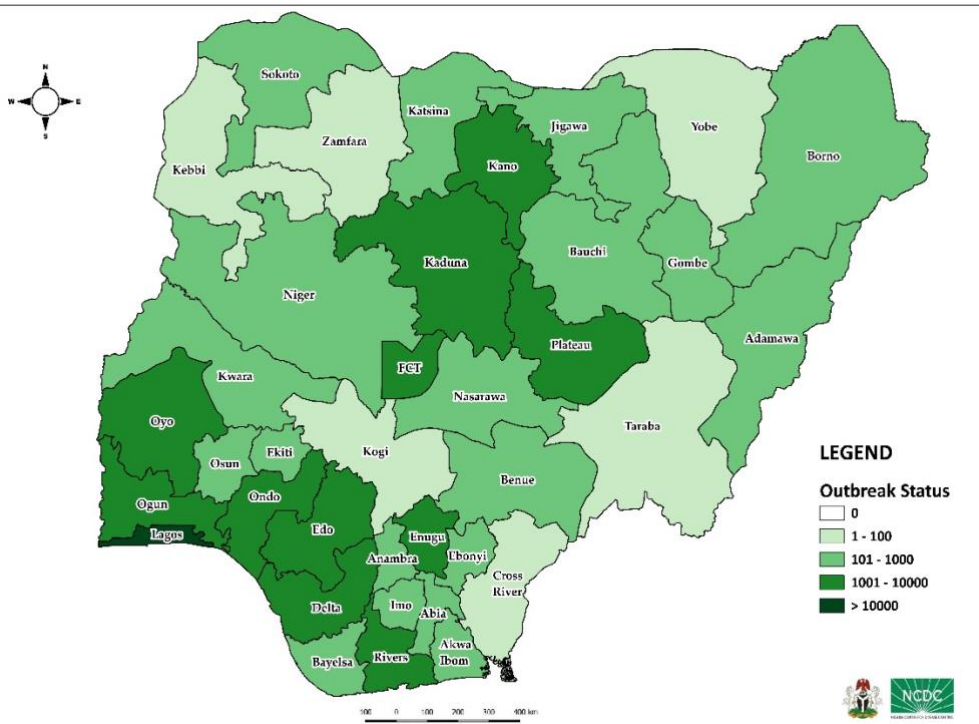

### HIGHLIGHTS

- Six hundred and one (**601**) confirmed cases were reported in the last 24 hours from **21** states – Lagos (404), FCT (37), Oyo (19), Ondo (14), Abia (13), Enugu (13), Kaduna (13), Edo (12), Kano (12), Kwara (11), Ebonyi (10), Nasarawa (7), Ogun (6), Osun (5), Delta (5), Niger (5), Plateau (4), Bayelsa (4), Katsina (3), Ekiti (2) and Imo(2)
- Eight hundred and eighty-two (**882**) discharges have been reported in the last 24 hours in **14** states – Lagos (684), Abia (64), Ogun (28), Plateau (27), Kaduna (18), Cross River (14), Edo (10), Gombe (9), FCT (8), Osun (8), Imo (5), Rivers (3), Ondo (2) and Oyo (2).
- One (**1**) death was reported in the last 24 hours in **one** state – Lagos (1).
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK34)

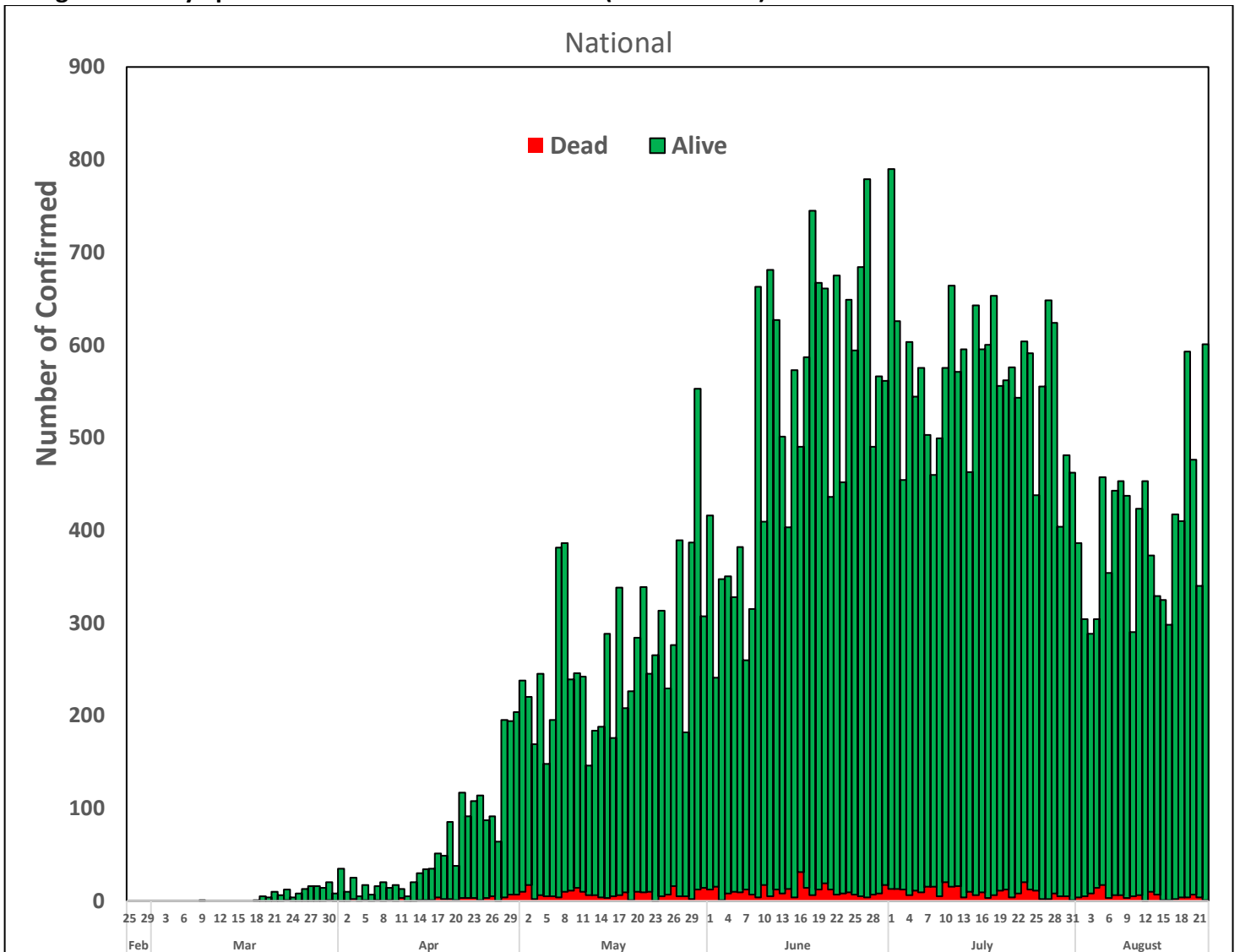
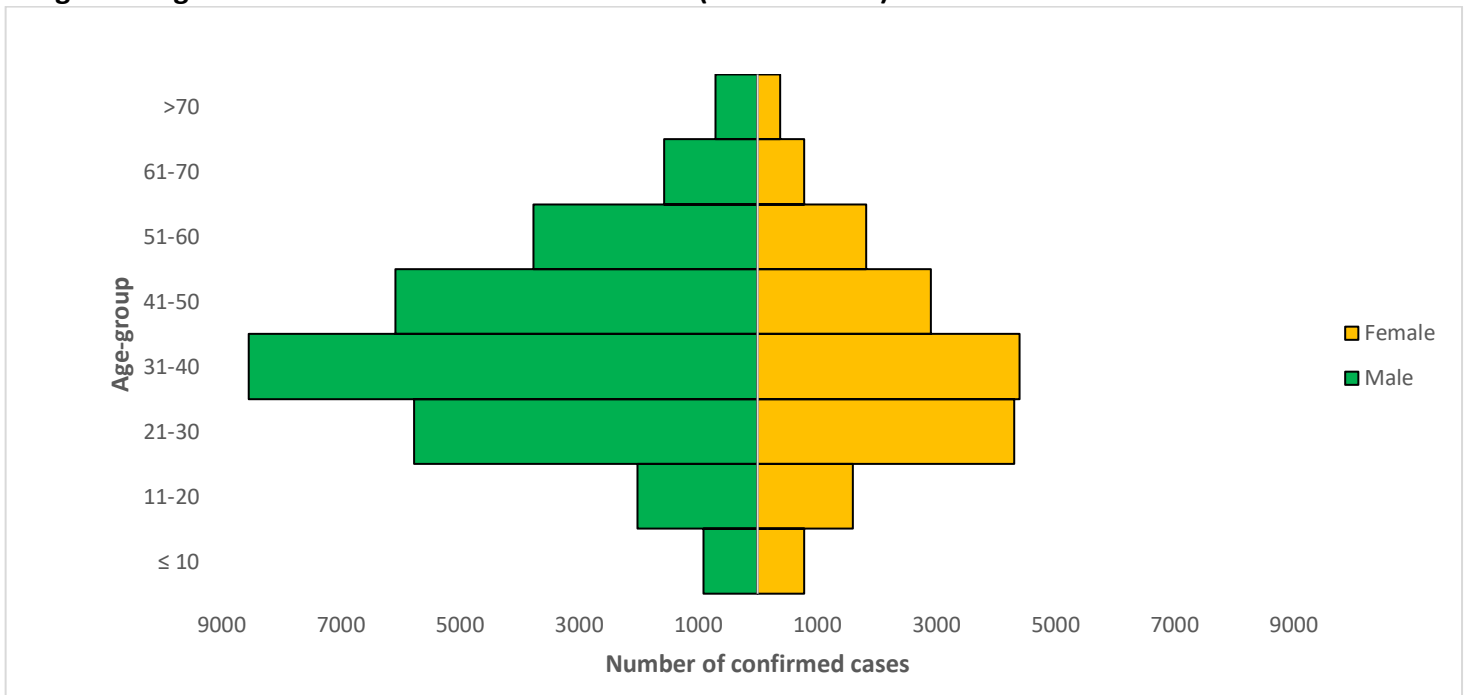


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK34)

## RESPONSE

On 28<sup>th</sup> February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Trained public and private school teachers on Infection Prevention and Control (IPC) strategies ahead of school reopening in Niger State**
- **Ongoing support for community engagement activities in 10 states in collaboration with partners**
- Trained technical advisors on strategies for implementation of prioritised COVID-19 Incident Action Plan (IAP) and deployed to 19 States
- Facilitated the accreditation/licensing of four (4) additional private labs for COVID-19 testing by the Medical Laboratory Science Council of Nigeria (MLSCN)
- Conducted Training of Trainers (ToT) workshop on IPC for Doctors from Nigeria Medical Association (NMA) and Health workers in Anambra State
- Deployed a month stock of Laboratory IPC materials to Laboratories in the network

- Deployed 360 android phones procured for Local Government Area (LGA) Health Promotion Officer (HPO) for reporting Risk Communication for Community Engagement (RCCE) activities
