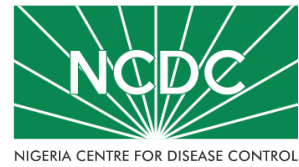


# COVID-19 SITUATION REPORT

## SITUATION REPORT 221

Tuesday, 6<sup>th</sup> October 2020



DATA AS REPORTED AND ACCURATE BY NCDC AS AT MIDNIGHT 6<sup>TH</sup> OCTOBER 2020

### HIGHLIGHTS

- One hundred and eighteen (**118**) confirmed cases were reported in the last 24 hours from **14** states – Lagos (41), Rivers (19), Osun (17), Nasarawa (13), Anambra (5), Kaduna (5), Edo (3), Kwara (3), Ogun (3), Ondo (3), Katsina (2), Niger (2), Akwa Ibom (1) and Plateau (1).
- Three hundred and fifty-seven (**357**) discharges have been reported in the last 24 hours in **eight** states – FCT (213), Plateau (76), Oyo (25), Rivers (20), Niger (10), Kaduna (6), Katsina (6) and Osun (1).
- **No** death was reported in the last 24 hours.
- All **36** states in Nigeria, and the FCT, have reported a confirmed case.

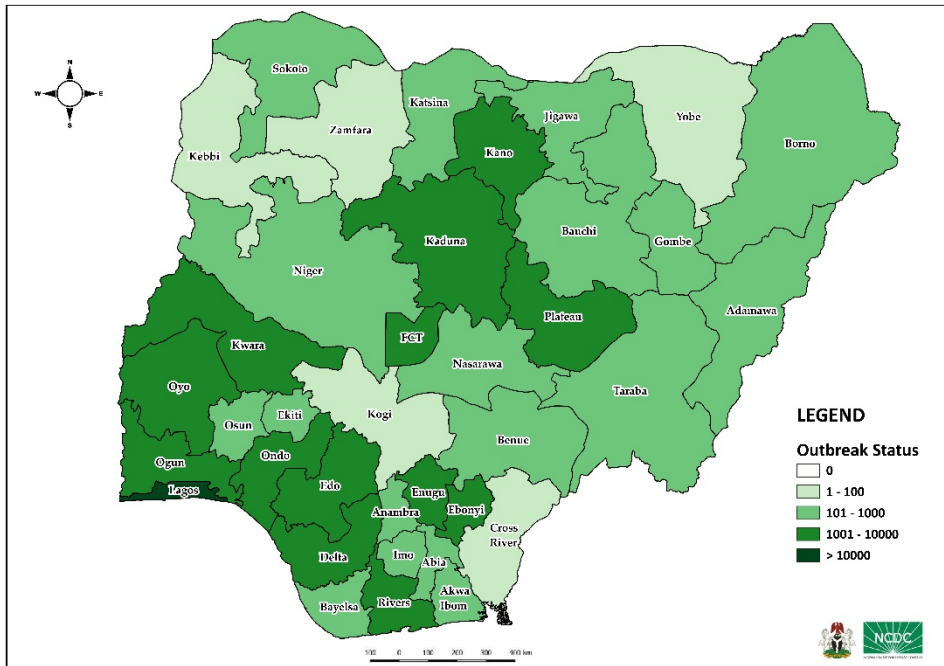

Figure 2: Daily Epidemic Curve of Confirmed Cases (WK9 – WK41)

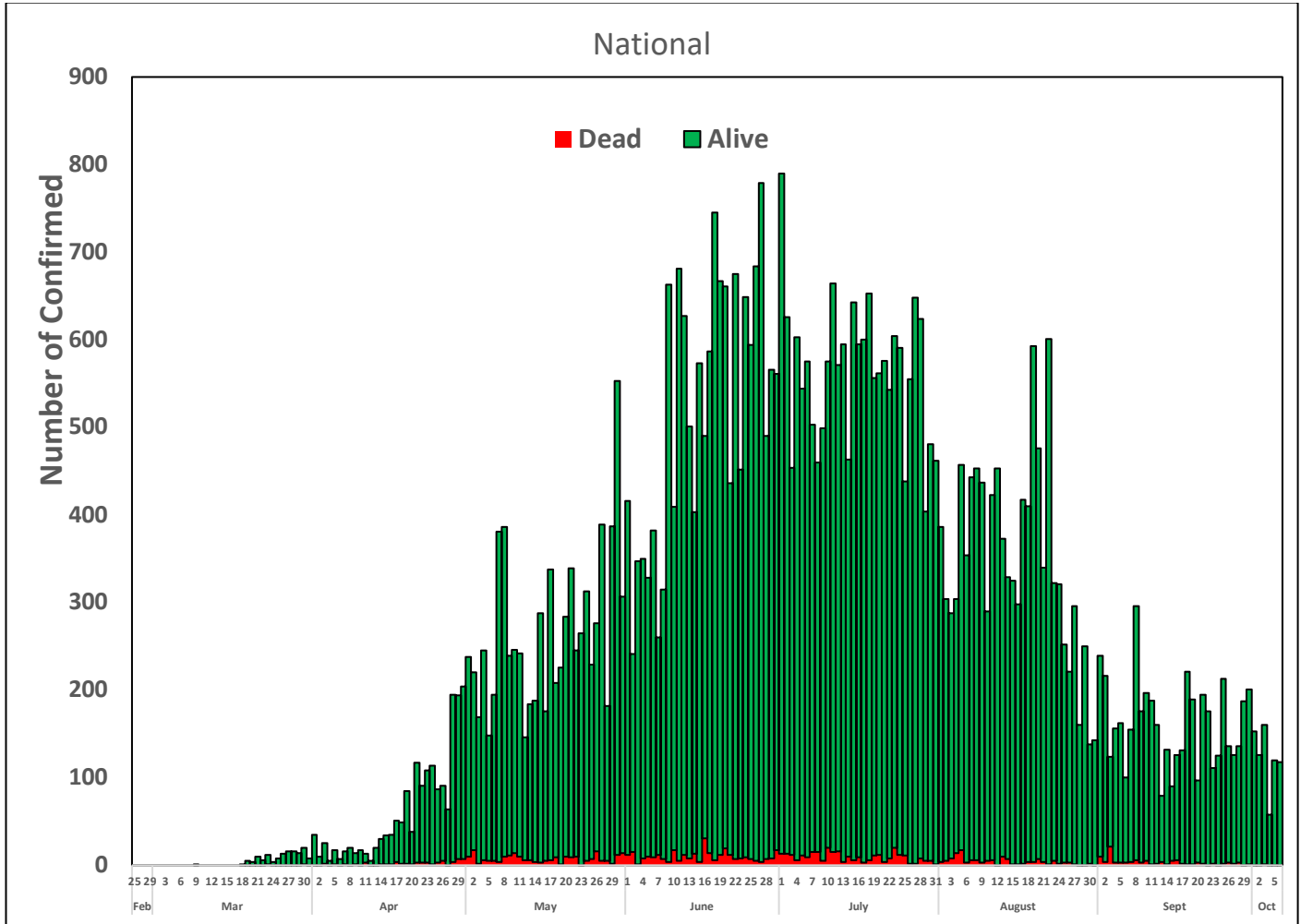
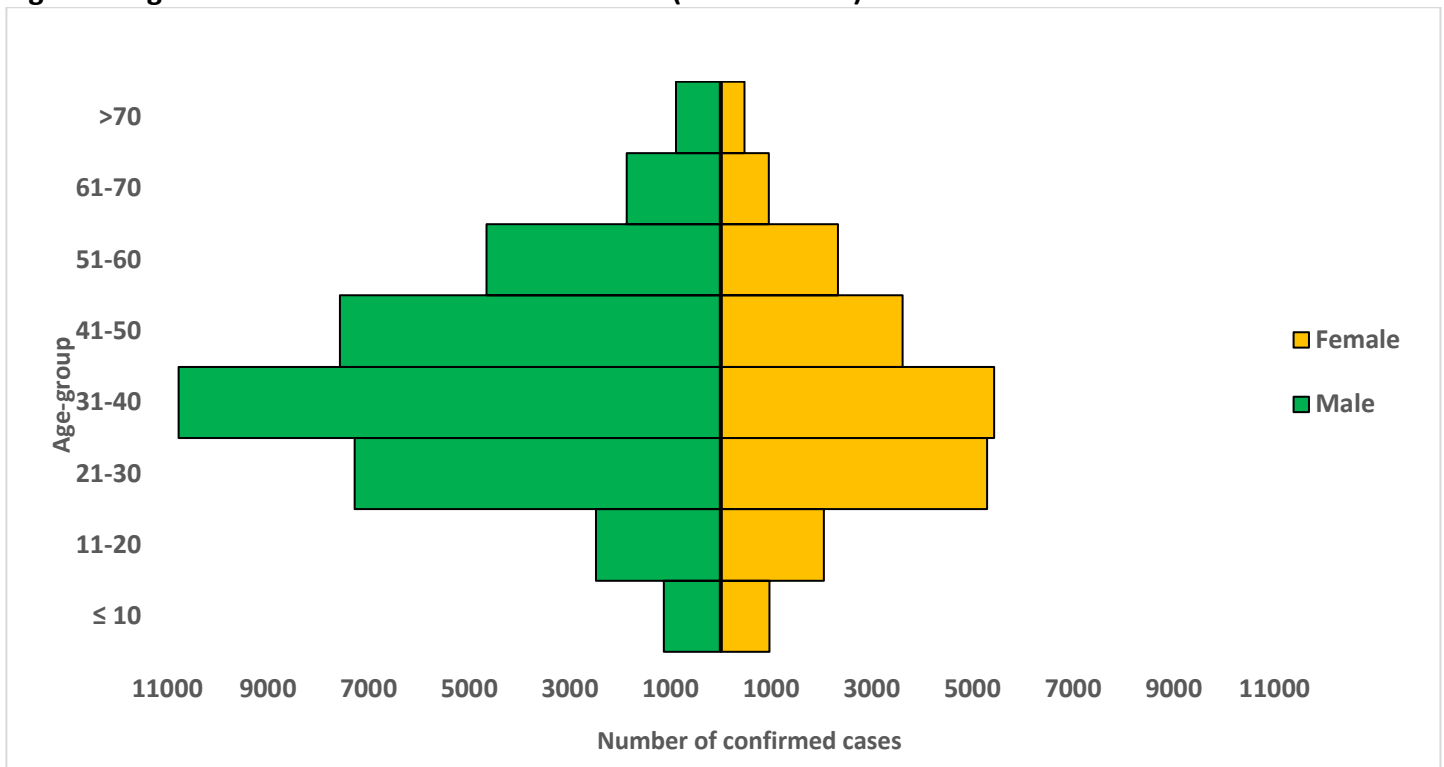


Figure 3: Age-Sex Distribution of Confirmed Cases (WK9 – WK41)

## RESPONSE

On 28<sup>th</sup> February 2020, a multi-sectoral Emergency Operations Centre (EOC) was activated at Level 3 – the highest emergency level in Nigeria –led by NCDC in close coordination with the State Public Health EOCs (PHEOC).

- **Ongoing training of Uniformed Services personnel on Infection Prevention and Control (IPC) with 20 participants from the North Central geopolitical zone**
- **Ongoing deployment of Personal Protective Equipment (PPE) to the laboratory network**
- **Held meeting with education partners on adaptation of Information, Education and Communication (IEC) materials for safe school re-opening**
- Provided supportive supervision at the Infection Prevention and Control (IPC) training of case managers in Oyo and Plateau States
- Ongoing engagement with partners and stakeholders on support for implementing and intensifying risk communication activities in states
